CONTRACTOR'S WORK AREA

THE RAILROAD WILL PROVIDE FLAGGERS UP AND DOWN THE TRACKS AT TIMES WHEN ANY MEN OR EQUIPMENT ARE OPERATING WITHIN 25.0 FEET OF THE CENTERLINE OF THE TRACK OR ANY TIME WORK IS OCCURRING ABOVE THE TRACK. 
