AN ORDINANCE ADOPTING THE EXISTING COUNTY CODE AND REPEALING CERTAIN PORTIONS THEREIN, CRAWFORD COUNTY, IOWA

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF CRAWFORD COUNTY, IOWA:

- SECTION 1. Purpose. Code of Iowa Section 331.302, Subsection nine; requires that once every five years a County shall compile its Code of Ordinances. This Ordinance readopts Ordinances already in effect and repeals certain portions.
