The Board of Supervisors met at 9:00 o'clock A.M. with Eric Skoog, Chairman presiding. All members were present.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

The Board acknowledged the change of wage for Aaron Bexten, Maintenance Employee II in the Engineer's Department.

A motion was made by Muhlbauer, seconded by Blum to approve the Liquor License for the Five Mile House.

Voting Aye: Blum, Muhlbauer, Schulz and Ulmer. Abstaining: Skoog. Motion passed.

A motion was made by Ulmer, seconded by Blum to approve the Liquor License for the Animal Pound Fundraiser in Deloit on August 11, 2018.

Motion passed unanimously.

A motion was made by Ulmer, seconded by Muhlbauer to approve the appointments of Jay Ford, Eileen Sailer and Kyle Schultz to the Crawford County Area Solid Waste Agency.

Motion was passed unanimously.

The Board met with Jeri Vogt, Crawford County Treasurer to discuss abating taxes and special assessments for parcel #13-11-407-0078 owned by the City of Denison. The Board of Supervisors would like to meet with the City of Denison before making a motion. No action was taken at this time.

A motion was made by Ulmer, seconded by Schultz to approve the Crawford County Sheriff's Union Agreement.

A motion was made by Ulmer, seconded by Blum to approve the applications for 65 impoundment structures, containing 241.82 acres with an assessed value of \$82,530 for the Assessed Year 2018 Water Impoundment Exemptions.

Motion was passed unanimously.

A motion was made by Blum, seconded by Ulmer to approve the Notice of Public Hearing and the publications thereof related to the adoption of an Ordinance establishing a policy for RAGBRAI Vending.
