The Board of Supervisors met at 9:00 o'clock A.M. with Kyle Schultz, Chairman presiding. Members present were Cecil Blum, Kyle Schultz, Eric Skoog and Dave Muhlbauer. Members Absent were Jeri Vogt.

Minutes of the previous meeting were read and approved.

Vogt arrived at the meeting at 10:04 o'clock A.M.

A motion was made by Muhlbauer, seconded by Vogt to approve the purchase of Smith Co Side Dump Trailer in the amount of \$53,000.

Motion was passed unanimously.

A motion was made by Blum, seconded by Skoog to approve being the fiscal agent for the Iowa State University Extension Office for Grant Applications.

Motion was passed unanimously.

The Board approved the Clerk of Court Fees for October 2019.

The Board received and reviews the Compensation Board's Recommendation for the Salaries of the Elected Officials for FY 2020/2021. The Compensation Board recommended a 4% increase for the Recorder, Treasurer and Auditor, a 4.5% increase for the County Attorney and Sheriff, and a 4% increase for the Board of Supervisors with a \$750 stipend for the Chairperson.
