WHEREAS, the Crawford County Board of Supervisors have considered the proposed FY2023 county maximum property tax dollars for both General County Services and Rural County Services, and

WHEREAS, a notice concerning the proposed county maximum property tax dollars was published as required and posted on county web site and/or social media account if applicable,

WHEREAS, a public hearing concerning the proposed county maximum property tax dollars was held on March 15, 2022 at 10am

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Crawford County that the maximum property tax dollars for General County Services and rural County Services for FY2023 shall not exceed the following:

General County Services - \$6,223,513, an increase of 8.38% from the prior year.

Rural County Services - \$3,665,904, an increase of 6.23% from the prior year.

Explanation of increases in the budget:

Rural Supplemental levy reduced by .10 for FY23. Requested tax dollars increased due to valuation increases.

The above tax rates do not include county voted levies, mental health and disabilities services levy, debt service levy and the rates of other local jurisdictions. Regarding proposed maximum dollars, the Board of Supervisors cannot adopt a higher tax asking for these levies following the public hearing. Budget year effective property tax rate is the rate that would be assessed for these levies if the dollars requested is not changed in the coming year.
