Amy Pieper with Crawford County Historic Preservation Commission gave the Board an update about the dismantling and relocating of the Bell Cabin. There are grants they can apply for but they need support from the community. A motion was made by Dozark, seconded by Heiden to contribute \$4,000.00 to the Bell Cabin for fiscal year 2025/2026.

Sara Meseck, Recorder, gave the Board a quarterly update. There as been increase in passports.
