The Board of Supervisors met at 9:00 o’clock A.M. with Dave Muhlbauer, chair presiding. Members present were Schultz, Dozark, Muhlbauer, Heiden, and Rosburg.

Minutes of the previous meetings were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

A motion was made by Schultz, seconded by Heiden to approve the following resolution:

Resolution Transferring Funds

NOW, THEREFORE, be it resolved by the Board of Supervisors of Crawford County, Iowa that:

the sum of Two Hundred Thirty-Four Thousand Eight Hundred Three Dollars (\$234,803) is hereby transferred from the General Basic Fund #0001 into the Secondary Road Fund #0020, and

the sum of One Million Four Hundred Seventy-Four Thousand Five Hundred Forty-Eight Dollars (\$1,474,548) is hereby transferred from the Rural Basic Fund #0011 into the Secondary Road Fund #0020.

Voting Aye: Schultz, Dozark, Muhlbauer, Heiden and Rosburg. Motion passed unanimously.

A motion was made by Heiden, seconded by Rosburg to approve the following resolution:

Resolution Transferring Funds

NOW, THEREFORE, be it resolved by the Board of Supervisors of Crawford County, Iowa that

the sum of Three Hundred Fifty Thousand Dollars (\$350,000) is hereby transferred from the General Basic Fund #0001 into the General Supplemental Fund #0002, and

the sum of Two Hundred Thousand Dollars (\$200,000) is hereby transferred from the Rural Basic Fund #0011 into the Rural Supplemental Fund #0012.

Voting Aye: Schultz, Dozark, Muhlbauer, Heiden and Rosburg. Motion passed unanimously.

The Board had a discussion about a possible ordinance for dogs at large. Some of the Supervisors have reviewed other counties’ ordinances and have shared with our County Attorney. Sheriff Rasmussen joined in the discussion and voiced some of his concerns.

A motion was made by Dozark, seconded by Rosburg to approve setting the time, date, and location for a Public Hearing for Budget Amendment for FY 2024/2025 for June 17, 2025, at 10:00 o’clock A.M. in the Board of Supervisor’s Board Room on the Second Floor of the Courthouse.

Motion passed unanimously.

A motion was made by Dozark, seconded by Heiden to approve the Law Enforcement Agreement with the City of Dow City and the Crawford County Sheriff’s Office.

Motion passed unanimously.

On motion duly seconded the Board adjourned at 11:04 o’clock A.M.
