The Board of Supervisors met at 9:00 o'clock A.M. with Dave Muhlbauer, chair presiding. Members present were Schultz, Dozark, Muhlbauer, Heiden, and Rosburg.

Minutes of the previous meeting were read and approved.

The Board approved the Clerk of Court fees for July 2025.

The Board approved the hiring of Kathy Singsank, PT RN, Public Health.

A motion was made by Schultz, seconded by Dozark to approve the Notice of Public Hearing and the publication thereof related to the reclassification of a segment of N Ave. between 120<sup>th</sup> St. and 130<sup>th</sup> St. from an Area Service "B" Road to an Area Service "A" Road for September 9, 2025 at 10:00 o'clock A.M in the Board of Supervisors room.

Motion passed unanimously.

Dan Mundt, CDC Tourism Coordinator, introduced himself to the Board and discussed some new ideas and updates on tourism in Crawford County.

The Board had a discussion about the mileage rules when a county vehicle is taken home. County will continue with the handbook policy. No action was taken.

A motion was made by Heiden, seconded by Dozark to approve the appointment of Sheri Vaughn to the Region XII Housing Authority Board of Directors for a term of October 1, 2025 – September 30, 2026.

Motion passed unanimously.

A motion was made by Rosburg, seconded by Schultz to approve the final passage of Crawford County Animal Control Ordinance after wavier of requirements under 331.302(6)(a)&(b).

Motion passed unanimously.

A motion was made by Rosburg, seconded by Heiden to authorize the Auditor to publish the Animal Control Ordinance.

Motion passed unanimously.

A motion was made by Schultz, seconded by Dozark to approve the DHS Tax Suspensions.

Motion passed unanimously.

A motion was made by Heiden, seconded by Schultz to approve the amended estimate for flooring for Sheriff's Office.

Motion passed unanimously.

The Board had a discussion about the proposal for the courthouse parking lot (15 S.12<sup>th</sup> St.) repairs. No action was taken at this time.

A motion was made by Dozark, seconded by Rosburg to approve the Tax Abatement for 1919 Hwy 39, Deloit, James & Lynn Brown for a new steel building/utility machine shed.

Motion passed unanimously.

At 10:37 o'clock A.M., a motion was made by Schultz, seconded by Heiden to open the Closed Session per Iowa Code 21.5(1)(c), which allows for a closed session. Motion passed unanimously. At 11:10 o'clock A.M., a motion was made by Heiden, seconded by Rosburg to close the Closed Session. Motion passed unanimously.
