

September 9, 2025

The Board of Supervisors met at 9:00 o'clock A.M. with Dave Muhlbauer, chair presiding. Members present were Schultz, Dozark, Muhlbauer, Heiden, and Rosburg.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

At 10:00 o'clock A.M., a motion was made by Schultz, seconded by Rosburg to open the public hearing for the reclassification of a portion of N Ave. between 120th St. and 130th St. said road lying generally along the North Line of Sec. 9-83-41 from Area Service "B" Road to Area Service "A" Road. Motion passed unanimously. There were no written objections or oral objections. At 10:02 o'clock A.M. a motion was made by Dozark, seconded by Heiden to close the hearing. Motion passed unanimously.

A motion was made by Heiden, seconded Schultz to approve the following resolution:

Crawford County Resolution #2025-34
Reclassifying certain Secondary Road from Area Service B Road to Area Service A Road.

WHEREAS, Crawford County desires to reclassify a certain road on the secondary road system in the county to provide for an increased level of maintenance; and

WHEREAS, Crawford County, after consultation with the Crawford County Engineer, has the authority to reclassify certain roads within the County as Area Service "A" roads pursuant to Iowa Code Section 309.57; and

WHEREAS, the Crawford County Board of Supervisors, after consulting with the Crawford County Engineer, desire to reclassify a certain road in Crawford County from Area Service "B" Road to Area Service "A" Road to provide for an increased level of maintenance in order to best utilize maintenance funds, and

WHEREAS, pursuant to Notice of Public Hearing duly published according to the Iowa Code, Public Hearing as held on September 9, 2025, at 10:00 a.m. in the Board of Supervisors room at the Crawford County Courthouse, Denison, Iowa, to hear support and/or objections from the public on road so designated.

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF CRAWFORD COUNTY that this County does hereby reclassify the road described as Area Service "A" road.

WILLOW TOWNSHIP T-83N R-41W

1. N Ave. between 120th St. and 130th St. Said road lying generally along the North Line of Sec. 9-83-41.

Voting Aye: Schultz, Dozark, Muhlbauer, and Heiden. Abstained: Rosburg. Motion passed.

The Board had a follow-up discussion with Randy Mahnke about the new County Animal Ordinance.

A motion was made by Rosburg, seconded by Heiden to approve the appointment of Jeff Mendenhall to the Veteran's Affairs Commission for a three-year term ending June 30, 2028.

Motion passed unanimously.

A motion was made by Schultz, seconded by Rosburg to approve the Weed Commissioner Annual Report.

Motion passed unanimously.

At 10:55 o'clock A.M., a motion was made by Heiden, seconded by Rosburg to open the Closed Session per Iowa Code 21.5(1)(c), which allows for a closed session. Motion passed unanimously. At 11:31 o'clock A.M., a motion was made by Schultz, seconded by Dozark to close the Closed Session. Motion passed unanimously.

A motion was made by Rosburg, seconded Heiden to approve the following resolution:

RESOLUTION 2025-35
Central Iowa Juvenile Detention Center
Compromise Settlement Agreement

WHEREAS Crawford County is a stakeholder in the Central Iowa Juvenile Detention Center (hereinafter CIJDC), and

WHEREAS the CIJDC is the Respondent in Hardin County Case No. CVCV102247, whereby Hardin County calls into question the validity of prior 28E agreements, and

WHEREAS the outcome of that litigation is uncertain, and Crawford County has an interest in the outcome of that litigation, and

WHEREAS the CIJDC Commission has voted 22-5 to approve the attached compromise settlement agreement resolving the litigation, and

WHEREAS the compromise settlement agreement is a compromise between Hardin County and the CIJDC that acknowledges the membership of counties joining the CIJDC through 2012 and also allows the remaining counties to maintain certain benefits that the litigation does not

otherwise guarantee, while also allowing the counties joining through 2012 to adopt a new 28E agreement and even vote to allow the remaining counties to regain full membership in the CIJDC, and

WHEREAS the Parties will file with the Court a consent decree memorializing the full terms and conditions of the Parties’ compromise settlement agreement following approval of the compromise settlement by a majority of the member counties.

THEREFORE, the Crawford County Board of Supervisors hereby approve and adopt the attached compromise agreement, and authorize the CIJDC to execute and present to the court a consent decree consistent with the attached compromise settlement.

Voting Aye: Schultz, Dozark, Muhlbauer, Heiden and Rosburg. Motion passed unanimously.
