The Board of Supervisors met at 9:00 o'clock A.M. with Dave Muhlbauer, chair presiding. Members present were Schultz, Dozark, Muhlbauer, Heiden, and Rosburg.

Minutes of the previous meetings were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

The Board approved Clerk of Court Fees for November 2025.

The Board approved the retirement of Joni Kienast, Legal Assistant, Attorney's Office.

The Board approved the hiring of Valerie Ipsen, FT Home Health/Hospice Clinical Manager, Public Health, Kailee Olivia Ipsen, FT Home Health/Hospice Nurse, Public Health, and Elizabeth Morales Garcia, Legal Assistant, Attorney's Office.

The Board approved the change of wage and status of Jason Blunk, FT Maintenance Employee IV, Engineer's Office.

A motion was made by Schultz, seconded by Rosburg to approve the following resolution:

Resolution Transferring Funds

NOW, THEREFORE, be it resolved by the Board of Supervisors of Crawford County, Iowa that

The sum of One Million Five Hundred Eleven Thousand Dollars (\$1,511,000) is hereby transferred from the Rural Basic Fund #0011 into the Secondar Road Fund #0020.

Paul Overton, Assessor, had a discussion with the Board about abatements and zoning.

A motion was made by Schultz, seconded by Heiden to approve the following resolution:

Resolution 2025-40
**CRAWFORD COUNTY RESOLUTION FOR A TEMPORARY MORATORIUM
ON UTILITY-SCALE SOLAR ENERGY PROJECTS**

WHEREAS, the Crawford County Board of Supervisors has authority under Iowa Code §§ 331.301, 331.302, and 335.3 to protect the public health, safety, and welfare and to regulate land use and development within the County;

WHEREAS, the Board of Supervisors finds that utility-scale solar development raises significant and evolving issues relating to land-use compatibility, agricultural preservation, drainage infrastructure, road use, decommissioning, financial assurance, and protection of neighboring property rights; and

WHEREAS, the Board of Supervisors does not intend to prohibit the personal use of solar energy by county residents; and

WHEREAS, the Board of Supervisors desires additional time to evaluate and consider policies and regulations relating to utility-scale solar energy projects to ensure such development is conducted in a manner consistent with a comprehensive plan by the County and the public interest; and

WHEREAS, a temporary moratorium is a reasonable and lawful planning tool to preserve the status quo while such review and consideration occurs, and is not intended to permanently prohibit solar development within the County.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Crawford County, Iowa, as follows:

1. Moratorium Imposed.

Effective immediately upon adoption of this Resolution, Crawford County, which includes the Crawford County Zoning Commission, shall not accept, receive, process, review, or approve any new applications, permits, rezoning requests, special use permits, variances, site plans, or other discretionary approvals for utility-scale solar energy projects in Crawford County.

2. Duration.

This moratorium shall remain in effect for a period of six (6) months from the date of adoption of this Resolution, unless sooner terminated or extended by further action of the Board of Supervisors.

3. Grandfathered / Previously Approved Projects.

This moratorium shall not apply to any solar energy project that received final approval from the County or Zoning Commission prior to the effective date of this Resolution, including but not limited to projects for which the County has approved a rezoning, special use permit, site plan, or other final land-use authorization. Such previously approved projects may proceed in accordance with the terms and conditions of their approval.

4. Purpose and Intent.

The purpose of this moratorium is to allow the County sufficient time to evaluate and consider potential policies and regulations related to utility-scale solar energy development. Nothing in this Resolution shall be construed as a permanent prohibition on solar energy projects, nor prohibit personal use of solar energy by county residents.

5. Severability.

If any provision of this Resolution is determined to be invalid or unenforceable by a court of competent jurisdiction, such determination shall not affect the validity of the remaining provisions.

Voting Aye: Schultz, Dozark, Muhlbauer, Heiden and Rosburg. Motion passed unanimously.

A motion was made by Dozark, seconded by Shultz to reappoint Jean Heiden to the Board of Health for 3-year term ending 12-31-2028.

Motion passed unanimously.

A motion was made by Dozark, seconded by Heiden to reappoint Mary Eiten to the Conservation Board ending 12-31-2030.

Motion passed unanimously.

A motion was made by Dozark, seconded by Heiden to reappoint Dr. Dennis Crabb as Medical Examiner ending 12-31-2027.

Motion passed unanimously.

A motion was made by Schultz, seconded by Dozark to reappoint Ashley Green, Alex Alvarez-Garcia, and Rachel Burns as Medical Examiner Investigators ending 12-31-2027.

Motion passed unanimously.

At 10:57 o’clock A.M., a motion was made by Rosburg, seconded by Heiden to open the Closed Session per Iowa Code 21.5(1)(c), which allows for a closed session. Motion passed unanimously. At 11:44 o’clock A.M., a motion was made by Dozark, seconded by Heiden to close the Closed Session. Motion passed unanimously.

On motion duly seconded the Board adjourned at 11:46 o’clock A.M.
