

January 13, 2026

The Board of Supervisors met at 9:00 o'clock A.M. with Craig Dozark, chair presiding. Members present were Schultz, Muhlbauer, Dozark, Heiden, and Rosburg.

Minutes of the previous meetings were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

The Board approved the Sheriff's Office quarterly report for October 2025 – December 2025.

The Board approved the hiring of Liz Morales-Garcia, Legal Assistant/Secretary, Attorney's Office and Amanda Dirks, Home Care Aide, Public Health.

Wendy Mueller (via Zoom), from West Central Community Action, presenting their year in review and a funding request of \$4,000. Fiscal Year 2025 West Central Community Action provided \$1,139,859.00 worth of services to Crawford County residents.

Dean Schade from IMWCA gave the Board an update on the workers' compensation for the year.

Kurt Miller, The Hoffman Agency, had a discussion with the Board on the valuation adjustment and premium update.

Tedd Bliesman, Chair, of the Compensation Board presented the Board with their recommendations for the elected officials for FY 2026/2027. \$12,000 for Treasurer, Auditor, and Recorder, \$7,600 (\$750 stipend for chair) for the Supervisors, \$17,525 for Attorney, and \$28,000 for the Sheriff. No action was taken at this time.

A motion was made by Heiden, seconded by Rosburg to approve the alcohol license renewal for The New Country Pumpkin, Inc.

Motion passed unanimously.

A motion was made by Muhlbauer, seconded by Schultz to approve the following resolution:

Motion passed unanimously.
