The Board of Supervisors met at 9:00 o'clock A.M. with Craig Dozark, chair presiding. Members present were Muhlbauer, Dozark, Heiden, and Rosburg. Member absent Schultz.

Minutes of the previous meetings were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

A motion was made by Rosburg, seconded by Heiden to approve the awarding of Project STP-S-CO24(135)—5E-24 HMA Widening w/HMA Resurfacing on L51, from South Corp. Limits of Charter Oak South 15 Miles to Intersection with Hwy 37 to Norris Asphalt Paving Co., LC in the amount of \$5,776,826.34.

Motion passed unanimously.

Zach Rasmussen, Emergency Management Coordinator, discussed with the Board the Verizon Lease Agreement. No Action was taken.

At 10:31 o'clock A.M., a motion was made by Muhlbauer, seconded by Heiden to open the Closed Sessions (quantity of 4) per Iowa Code 21.5(1)(c), which allows for a closed session. Motion passed unanimously. At 12:16 o'clock P.M., a motion was made by Heiden, seconded by Muhlbauer to close the Closed Sessions. Motion passed unanimously.
