Minutes of the previous meetings were read, corrected and approved.

The Board approved the Clerk of Court Fees for April 2026.

The Board approved the hiring of Anthony Trejo, Seasonal Park Attendant, Conservation.

A motion was made by Schultz, seconded by Muhlbauer to approve the Cost Allocation Services 3-year contract renewal, not to exceed \$4,450.

the sum of One Million Five Hundred Ten Thousand Seven Hundred Sixty Dollars (\$1,510,760) is hereby transferred from the Rural Basic Fund #0011 into the Secondary Road Fund #0020.

the sum of Two Hundred Thousand Dollars (\$200,000) is hereby transferred from the Rural Basic Fund #0011 into the Rural Supplemental Fund #0012.

A motion was made by Heiden, seconded by Muhlbauer to approve the following resolution:

the sum of Fifteen Thousand Dollars (\$15,000.00) is hereby transferred from the General Fund #0001 into the Special Revenue Fund #0049.
