

June 23, 2026

The Board of Supervisors met at 9:00 o'clock A.M. with Craig Dozark, chair presiding. Members present were Schultz, Muhlbauer, Dozark, Heiden, and Rosburg.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

The Board approved the Clerk of Court fees for May 2026.

The Board approved the change of wages for County Attorney's Office, Sheriff's Office, and Louise Galbraith - Veterans Affairs/General Relief.

The Board approved the change of status for Amanda Dirks - PT Health Aide - Public Health, Kellie Lemon-Steinkuehler - FT Jailer, and Shannon Camine - FT Jailer, Sheriff's Office.

A motion was made by Heiden, seconded by Schultz to approve the Notice of Public Hearing and the publication thereof related to the reclassification of F Ave between 1131 F Ave and 120th St. from an Area Service Road B to an Area Service Road A, on July 7, 2026 at 10:00 o'clock A.M. in the Board of Supervisors Room.

Motion passed unanimously.

At 10:00 o'clock A.M., as advertised, a motion was made by Schultz, seconded by Heiden to open the public hearing regarding the Budget Amendment for FY 2025/2026. Motion passed unanimously. There were no written or oral objections. A motion was made by Muhlbauer, seconded by Heiden to close the public hearing at 10:12 o'clock A.M. Motion passed unanimously.

RESOLUTION NO. 2026-24

A RESOLUTION DESIGNATING THE OFFICIAL PHYSICAL POSTING LOCATION FOR PUBLIC MEETINGS AND AGENDAS PURSUANT TO IOWA CODE CHAPTER 21 AND HOUSE FILE 2490

WHEREAS, the Crawford County Board of Supervisors (the "Board") is a governmental body subject to the requirements of the Iowa Open Meetings Law, Iowa Code Chapter 21; and

WHEREAS, the General Assembly of the State of Iowa enacted House File 2490, effective upon enactment, which amended Iowa Code section 21.4; and

WHEREAS, under the provisions of HF 2490, governmental bodies are required to designate annually a prominent and conspicuous place which is easily accessible to the public where meeting notices and tentative agendas are posted and visible to the public at all times; and

WHEREAS, HF 2490 also requires notice and tentative agenda to be posted on the governmental body's primary internet site.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Crawford County, Iowa:

Section 1: Official Posting Location

The Board hereby designates the following prominent, conspicuous, and publicly accessible location as the official physical site for the posting of all public meeting notices and tentative agendas:

- The glass exterior door, facing outward on the east side of the Crawford County Courthouse, located at 1202 Broadway, Denison, Iowa, visible and accessible to the public 24 hours a day.

Section 2: Internet Posting

In addition to the physical posting location designated in Section 1, all public notices and tentative agendas shall be posted and regularly maintained on the county’s primary internet site at: www.crawfordcounty.iowa.gov

Section 3: Compliance with Prior Notice Requirements

Nothing in this resolution shall supersede the requirement to advise news media who have filed a request for notice with the county, or the requirement to fulfill the 24-hour advance notice of meetings as mandated by Iowa Code section 21.4.

Section 4: Effective Date

This resolution shall be in full force and effect from and after its passage and approval as provided by law.

Motion passed unanimously.

A motion was made by Schultz, seconded by Muhlbauer to approve the Verizon Lease Agreement. \$1,550.00 through September 1, 2029 and 3% increase September 1, 2030 and each year anniversary.

Motion passed unanimously.

The Board had a discussion about a Moratorium on Data Center permitting and construction.

On motion duly seconded the Board adjourned at 11:37 o’clock A.M.
