
**1.) E 1/4 CORNER 20-84-38 CRAWFORD COUNTY, IOWA:**  
 FOUND CONCRETE MONUMENT, 2" DEEP.  
 THIS MONUMENT MATCHES WITHIN REASON THE POSITION AND MONUMENTATION SHOWN ON EXISTING CRAWFORD COUNTY ENGINEER'S OFFICE SECTION CORNER REFERENCE TIES.  
 THIS CERTIFICATE IS BEING PREPARED BECAUSE: THERE IS NO CERTIFICATE FOR THE CORNER ON FILE WITH THE RECORDER OF THE COUNTY IN WHICH THE CORNER IS LOCATED.




**2.) CENTER OF SECTION 20-84-38 CRAWFORD COUNTY, IOWA:**  
 NO RECORD OF CORNER. SEARCHED ALONG FENCE WITH TILE PROBE AND FOUND NOTHING. SET 5/8" REBAR WITH ORANGE PLASTIC CAP STAMPED "J KRUEGER 16749", 2" ABOVE GROUND, ONLINE BETWEEN THE N 1/4 CORNER AND S 1/4 CORNER AND INLINE WITH EAST-WEST FENCE.  
 THIS CERTIFICATE IS BEING PREPARED BECAUSE: THERE IS NO CERTIFICATE FOR THE CORNER ON FILE WITH THE RECORDER OF THE COUNTY IN WHICH THE CORNER IS LOCATED.



**3.) S 1/4 CORNER 20-84-38 CRAWFORD COUNTY, IOWA:**  
 REFERENCE TIES FROM THE CRAWFORD COUNTY ENGINEER'S OFFICE INDICATE THAT A CONCRETE MONUMENT WAS SET AT THIS CORNER ON 5/21/1942. THIS MONUMENT WAS 19' WEST OF THE CORNER POST AT THAT TIME. SEARCHED WITH TILE PROBE AROUND EXISTING CORNER POST AND ALSO 19' WEST OF CORNER POST AND FOUND NOTHING. OCCUPATIONAL EVIDENCE INDICATES THAT THE CURRENT FENCE IS BEING USED AS THE PROPERTY LINE. SET 5/8" REBAR WITH ORANGE PLASTIC CAP STAMPED "J KRUEGER 16749", 2" ABOVE GROUND, ON NORTH SIDE OF CORNER POST.  
 THIS CERTIFICATE IS BEING PREPARED BECAUSE: THERE IS NO CERTIFICATE FOR THE CORNER ON FILE WITH THE RECORDER OF THE COUNTY IN WHICH THE CORNER IS LOCATED.
